

EXTENDED SCHOOLS TERMS & CONDITIONS

Parents copy to keep for reference

- **1. BOOKINGS:** All bookings can be made via 'School Money'. You will find the Extended Schools Clubs under the 'Clubs' tab.
- **2. RISE & SHINE operates as a morning drop in service**. Although advance bookings are preferred for administration purposes. Parents may use this on-the-day service. (£5.00 per session).
- **3. DISCOVERY**: Advance bookings are recommended to secure places (£14.50 per session). However last minute or onthe-day bookings are accepted, subject to availability. Last minute or on-the-day bookings will incur a higher fee (£16.00 per session). These sessions must be booked via telephone call School Office **01932 348961 option 3**
- **4. CANCELLATION NOTICE:** For safeguarding of your child .Please inform the Extended Schools Manager if you no longer require your booked session.

All cancellations must be made via telephone, Voice mail or email before 12:00 Midday (01932 348 961 option 3). Cancellations after 12.00 midday will incur the session fee of £14.50.

- 5. Please note: The school office will not share reported absences with Rise & Shine or Discovery.oo
- 6. PAYMENTS: Payments for Rise & Shine and Discovery must be via 'School Money.'
 We accept Childcare Vouchers/GOV Child Tax free scheme: If you are paying using Childcare Vouchers or using GOV Child Tax free scheme, please call or email Miss Moore (Extended School Club Manager) on 01932 348 961 option 3 /nicki.moore@west-byfleet-junior.surrey.sch.uk, who will advise procedure for this payment.

 We are unable to accept cash payments.

7.REFUNDS: Refunds will not be made for cancellations after 12:00 midday. Please note staff and resources are paid for in advance of all bookings.

Childcare Voucher: Please be aware that refunds may incur an admin charge when paying by vouchers due do administration for crediting.

- **8. EXTRA CURRICULUM CLUBS (Late arrival for Discovery):** If your child is attending extra curricular After-school clubs i.e. Sport/Music/Coding or participating in a school Sporting Event or school trip, please inform Extended School Manager in advance so we are aware of when to expect the arrival your child.
- **9. COLLECTION**: If an adult unfamiliar to the school is collecting your child, please ensure you have informed **DISCOVERY CLUB** in advance.
- Children will <u>not</u> be released to any person under the age of 18 years unless parents have informed and made arrangements with Miss Moore in advance.
- We will not release a child to anyone, other than those indicated on the Registration Form, unless the Extended Schools Manager has been advised otherwise.

10. LATE COLLECTION:

Please notify the club manager by 17:45 at the latest on: 01932 348 961 option 3

Occasionally unavoidable delay cannot be helped and although we are sympathetic to unforeseen circumstances, our professional and caring staff should not be taken for granted. Parents must make every effort to inform the club if they are running late and that other arrangement have been made for the collection of your child.

Late collection of children will incur a fee of £6.00 up to the first five minutes and £1.50 per minute thereafter. Two members of staff will remain with the children at all times until all children have been collected.

11. SAFEGUARDING: We take our duty to safeguard children very seriously, if arrangements to collect a child are not fulfilled and we are not notified of any delay, we will endeavour to telephone the authorised additional contact numbers on file. If by 18:00, no arrangement has been made to collect a child, the Designated Safeguarding lead (DSL) will be informed.

- **15. PERSONAL PROPERTY:** Personal property is brought in at your own risk. Rise & Shine and Discovery cannot be responsible for damage, loss or theft .
- **16. RISE & SHINE AND DISCOVERY PROPERTY:** Respect and proper use of all Rise and Shine and Discovery property and equipment is essential and must be maintained at all times. Parents will be informed of any damages caused and misuse of equipment.
- **17. BEHAVIOUR EXPECTATIONS:** Exemplary behaviour is expected by all children using the Extended Schools provision. Any unacceptable, inappropriate or disruptive behaviour will not be tolerated. Continuous unacceptable behaviour by any child, will be reported to the Extended Schools Manager who will inform parents.

RISE & SHINE and DISCOVERY reserves the right to exclude any child from the club who behaves in a disruptive, unacceptable or an inappropriate manner as this may put other children at risk.
